Process for Review of the Regional Strategy

1. Purpose of the report
 - 1.1 At the last meeting of the Board it was agreed that proposals should be brought forward for the review of the Regional Improvement and Efficiency Strategy (RIES).
2. Background
 - 2.1 The appendix to this report sets out a proposed process, responsibilities and timetable for the review of the RIES for 2009/10 as follows:-
 - Item 1: a review against the results of the benchmarking exercise considered by the Board at the last meeting
 - Item 2: a review against the outcome of a written consultation exercise with regional/sub-regional stakeholders.
 - Item 3: a review against common priorities identified from sub-regional strategies following their approval by the Board
 - Item 4: a review against priorities identified in a written consultation exercise with professional groups in the region
 - Item 5: a stakeholder consultation seminar to consider the results of the above and help develop 'ownership' of a revised RIES for 2009/10
 - Items 6/7 taking account of all of the above the Board agree the revised RIES for submission to LGA/Government
3. Recommendation
 - 3.1 It is recommended that the Board consider and agree the proposed process.
